And whereas _____, hereinafter called "Buyer" is / are purchasing the cat / kitten described above. The seller does hereby convey to buyer ownership of the above described cat / kitten under the guarantees and conditions set forth above and below and with no other guarantees or conditions:

Buyer accepts responsibility for caring for this animal and agrees to provide a proper environment with sufficient human interaction and exercise toys and cat scratching devises to maintain social and physical needs, proper diet and maintained pest free environment, and only supervised outdoor visits with yearly vet visits for excellent medical care if needed.

Buyer understands that declawing is a removal of the last joint of the toes that can alter the personality and behavior of the cat / kitten. Health and temperament guarantee are void if cat/kitten is declawed.

Buyer understands that the current trend to early alter this slow-maturing breed at 4 months, instead of breeder recommended 7-9 months will void health guarantee and may present elder life problems.

Seller guarantees cat / kitten to be free of any visible and known hereditary deformities and genetic diseases that may appear later, up until 2 years of age.

Enactment of Health guarantee requires proof of health examination by a licensed veterinarian within 3 working days of taking possession of cat / kitten. Seller is not responsible for any contagious diseases after this period.

Health guarantee is valid for up to one year from the date of purchase if kitten is not exposed to any other cats and applies only with written confirmation from a licensed veterinarian and receipt of necropsy report. Guarantee covers replacement of cat / kitten with another of equal or greater value. Seller is not responsible for any veterinary expenses incurred by Buyer if cat / kitten is kept by Buyer past the 3 day period. All veterinary expenses incurred past the 3 day period are the responsibility of the buyer.

Buyer's signature indicates he / she has reviewed and discussed this contract with Seller prior to taking possession of cat / kitten and is in full agreement with and approval of the above terms and conditions.
